Description:

Curlex III erosion control blanket (ECB) is a natural, stitched excelsior blanket that provides a temporary organic cover to reduce erosion, protect seeds, enhance germination, and hasten re-vegetation. Curlex III is furnished in rolls with polyethylene wrapping to protect against the elements prior to installation, and may be ordered in Master-Paks of fifteen rolls banded together to minimize material handling requirements. Curlex III is also available as QuickGRASS® (Dyed Green). ECB shall be Manufactured in the U.S.A.

Curlex III has a design soil loss ratio (event-based RUSLE C factor) of .027 and is typically suitable for slopes up to 1:1. Curlex III is rated for channel flows up to 10.5 ft/s (3.2 m/s) and 3.0 lb/ft^2 (144 Pa) shear stress.
